

**AGREEMENT BETWEEN TELANGANA TEACHERS JOINT ACTION
COMMITTEE AND SCHOOL EDUCATION DEPARTMENT HELD ON
17.10.2011**

1. The details of representatives of TTJAC/TGRJAC and the representatives on behalf of School Education Department are as shown in the annexure.
2. After detailed discussions the following decisions are agreed upon.
3. As regards the demand to introduce bill on Telangana State in Parliament, the matter rests and falls within the purview of Government of India. However, the Hon'ble Minister for Secondary Education agreed to convey the strike undertaken by the teachers and their sentiments to the State and Central Governments.
4. As regards the request to withdraw G.O.No.177, it is clarified that the matter is sub-judice. The Advocate General shall be consulted in the matter.
5. It is agreed that the period of absence from 16.09.2011 to 17.10.2011 will be compensated by working for 16 days on holidays which will be treated as duty.
6. This shall apply for all teachers, apprentice teachers, vidya volunteers, contract teachers, teachers and part time teachers working in all Residential schools, lecturers in DIET, CTE, IASE, SCERT, SIET, SSA, RMSA and C&DSE and all non teaching staff working in the schools only.
7. As regards the request to withdraw ESMA orders, it is clarified that the same have not been invoked so far against any of the employees. The request for withdrawal of ESMA in Residential Schools shall be examined as per the rules.
8. On the request to withdraw the criminal cases against certain teachers, it is clarified that Government have to examine the same on a case by case basis keeping in view the nature and gravity of the offence involved and will be considered sympathetically.

9. In pursuance of the above the TTJAC agrees and assures that all the teachers will resume duties with immediate effect i.e., 18.10.2011.
